The BSIF PPE Helpline - a dedicated support service administered by the British Safety Industry Federation. This expert helpline was established in 2024 specifically to help remove barriers around sourcing reliable and compliant PPE.

The helpline is operated by PPE and safety specialists who provide impartial, timely guidance across a wide range of topics - no sales pitch, just practical advice. Whether you're a duty holder, category manager, or safety professional, you can rely on their expertise.

#### When to Contact the PPE Helpline

- Fit-for-purpose PPE: Confirm whether selected items are suitable for specific hazards, use-cases, or working conditions.
- Regulatory support: Get clarity on UK and EU legislation, including PPE Regulation 2016/425, UKCA and CE marking requirements, and post Brexit certification nuances.
- Non compliance concerns: Check products and certification, report suspicious or potentially unsafe products; the BSIF has found up to 85 % of PPE from nonmember suppliers failed compliance testing.
- Product advice & selection: Receive guidance on identifying suitable PPE & safety products, understanding documentation, and checking product markings and certifications.
- Respiratory Protective Equipment (RPE): Support with assessing general RPE options, and advice on face-fit testing to ensure your team is protected.

**Bad Vibrations**, A new campaign tackling the widespread confusion surrounding Hand-Arm Vibration Syndrome (HAVS) has just launched, produced by BSIF (British Safety Industry Federation) – the UK's Trade Association for the Safety Industry.

More than 2 million people are at risk of developing HAVS every year due to repetitive use of vibrating tools. No one should jeopardise their long-term health while doing their job. With the right precautions taken early, this painful and sometimes irreversible condition can be prevented.

## **HSE Safety Alert**

**Excavators: Use of safety control lever or isolation devices** 



HSE has published a safety notice aimed at excavator operators, slingers and anyone working near them.

There is a risk that people can be struck by the excavator or a load if the operator does not use the safety control lever or isolation device correctly.

If there are people in the operational arc of an excavator or similar mobile plant, the safety control lever should be applied, or other methods used, to isolate the machine, while it is at rest (ticking over).

Research shows unintended movements of plant occur, but use of a safety control lever or isolation device can prevent this.

Dutyholders must, so far as reasonably practicable, ensure the safety of people in the working arc of slewing plant and any load, with proper planning, management and monitoring of work activities.
