Legal Opinion

08.02.2016: Email from Louise Mansfield (Louise.Mansfield@pinsentmasons.com)

I have spoken to one of my IP lawyer colleagues about the copyright issue.

- Essentially, anything produced by a third party will have copyright in it belonging to that third party. It doesn't actually have to say "copyright of" on it.
- Given the email below, it seems that BHSEA can re-publish information from the HSE so long as it attributes it as being from the HSE.
- It is possible, albeit perhaps unlikely, that if BHSEA published any other material belonging to a third party on the website, that third party could take action against BHSEA. The third party could sue for damages but is more likely to just ask for it to be taken down.
- The only complete way to avoid any breach of copyright is to ask the third party to consent to BHSEA publishing the materials. If they agree, they can't then take any action for breach of copyright. This may however be unrealistic. BHSEA could put links to third party websites / documents this would still technically breach copyright but is less likely to result in any action being taken than actually putting the entire document on the BHSEA website.
- In terms of copying across images (such as the one from the Australian blog), the same rules above would apply. Obtaining consent is again likely to be unrealistic and given the risk of any action is low, I would say that using HSE (or other government or public sector) images may be better (given the email below) but if you really want to use others, the source should be named and we would just have to take the risk of action.
- It is worth adding a clause to the website along the following terms to ensure BHSEA is not liable if any of the information is incorrect:

...... at our local Church we have been advised to be very careful about using photographs and cartoons. Apparently other Churches have been using things taken from the internet on their Facebook, and Web Sites, and this has been noticed by the copyright holders/copyright enforcement lawyers, who then successfully took legal action. Charitable status was no defence, because charities have assets and are therefore worth suing.

The advice which we have received is essentially:

- Check the copyright status of anything that is on the internet. There are some sites offering genuine copyright free materials.
- Check the Meta data that is attached to an image. Because it is through meta data that most owners assert both ownership and copyright.
- Just because it does not have a water mark, does not mean that it is 'free to use'. Because water marks can put potential purchasers off an image, they are often not used by vendors. Hence the importance of the legal warnings on the website and the meta data.
- The recent legal cases have had quite an impact, and our Diocese has instructed it's Churches to not use any internet images and in fact we now have a 'NAS box' and a set of volunteer photographers who take photos, give the copyright to the Charity/Church and place the photos in the NAS Box. The people who run the website, Facebook pages, magazines, etc., take images from the NAS Box first. If they can't find something suitable, then they contact the volunteer photographers and request a photograph.
 I would suggest that, when it comes to copyright, legal advice is a good idea, as is keeping records of when copyright owners have given permission for you to use one of their images.
